#### Personal Protective Rule

OSHA finalized the personal protective equipment rule on December 12. This rule was a clarification to ensure that employers know they are required to provide PPE to every employee. If an employer does not provide the equipment to every employee they can be cited for the violation on a per-employee basis. The clarification also involved training provided to each employee.

#### Changes to Georgia Emergency Rule for Combustible Dust

On 28 October 2008, Georgia's Insurance and Safety Fire Commissioner's office issued a notice of emergency rulemaking regarding Chapter 120-3-24-0.12, Loss Prevention Due to Combustible Dust Explosions and Fire. The emergency rules may be found at http://www.gainsurance. org/safetymfg/Home.aspx. These rules will expire 25 February 2009 and are still a work in progress.

In our roles as occupational and environmental health and safety professionals, we may be asked for input from the media, either a full interview, or a quote, or other variations on that theme. Here are some helpful tips from AIHA's public relations staff.

- do your homework
- know the audience
- understand the context

- an interview is not a PR opportunity
- develop core messages
- don't talk too much
- watch the jargon, acronyms
- don't lose your cool
- be proactive if you need to
- remember: you are never off the record
- the reporter is not your friend
  - respect deadlines and be sure to

follow up

- don't ask to see the story before
   it runs it's the reporter's choice
   to offer you the chance to
   review, not yours
- evaluate the results critique it

   did you get your core message across? Did you fall into any traps? What might you do differently next time?

#### **Revised OSHA Field Operations Manual Issued**


A revised Occupational Safety and Health Administration (OSHA) Field Operations Manual now provides OSHA Compliance Officers with a single source of updated information and guidance to more effectively protect employees from occupational injuries, illnesses, and fatalities.

The Field Operations Manual is

the guiding document for OSHA's Compliance Officers, whose mission is to assure the safety and health of America's working men and women. The manual assists Compliance Officers in scheduling and conducting inspections, enforcing regulations, and encouraging continual improvement in workplace safety and health. The manual also

guides Compliance Officers on how to inform employers about cooperative programs—such as On-Site Consultation, Strategic Partnerships, and the Voluntary Protection Program—to help them eliminate potential or existing hazards from the workplace.


#### **Georgia State Defense Force**

As an industrial hygiene professional you carry out your daily duties of protecting the safety and health of employees or clients. Have you ever considered giving back to your state or community by using your expertise to help others in the event of a crisis or disaster? Perhaps you should consider service in the Georgia State Defense Force whose mission is: When ordered by the Adjutant General, provide an organized, trained, disciplined, rapid response volunteer force to assist state and local government agencies, and civil

relief organizations in impending or actual emergencies to assure the welfare and safety of the citizens of Georgia.

The Georgia State Defense Force (GSDF) is part of the Georgia Department of Defense, like the Georgia Army National Guard or the Georgia Air National Guard. However, unlike those agencies the GSDF cannot be become federalized and sent out of the country. The emphasis here is on "volunteer." Although a "military" organization, the GSDF serves at the direction of the Governor through the Adjutant General.

Our colleague, Gerald Burklow, Global Manager of EHS for Cisco (Scientific Atlanta) in Lawrenceville is also 1st LT Burklow, HazMat Platoon Leader, 911th Support Command within GSDF and operates out of Atlanta.
